Before using the Falcon London Heliport HLS, the following must be completed, signed and returned together with copies of your Property, Third Party and Public Liability Insurance policies which must be valid at all times when using the HLS. Furthermore a copy of our insurance conditions must be forwarded to your insurers and they must be advised that we are named on your Third Party and Public Liability Insurance as an additional assured and that the relevant underwriters have agreed to waive subrogation rights against our company.

INSURANCE CONDITIONS APPLICABLE TO THE USE OF FALCON LONDON HELIPORT HELICOPTER LANDING SITE INDEMNITY, INSURANCE AND OTHER OBLIGATIONS

1.0 The Customer shall indemnify and hold harmless the Company (Falcon London Heliport) from and against any and all claims, losses, demands, actions and liabilities (including legal expenses) ('Claims') which the Company may incur (directly or indirectly) as a result of the use of the Falcon London Heliport HLS at West Ferry Road or other Falcon London Heliport sites including but without limitation Claims arising out of:

- 1.1 Pilot error, or negligence, or wilful misconduct, by the Customer or by its officers, employees, servants or agents (including helicopter pilots) or arising from any of the risks against which the Customer is obliged to effect insurance cover under these conditions;
- 1.2 Any defect in any of the Customer's helicopters, plant or equipment;
- 1.3 Any and all claims by the Customer's officers, employees, servants or agents (including helicopter pilots)

2.0 As a condition of use of the Falcon London Heliport HLS, the Customer shall:

- 2.1 Maintain with a reputable insurer third party and public liability insurance in respect of any helicopters using the Falcon London Heliport HLS and of the use of such helicopters, for amounts and on terms which are prudent and adequate in all the circumstances and in any event for an amount of at least £10 million and against claims by passengers, crew, members of the public and/or the Company for death, personal injury and/or property damage (including damage to the Falcon London Heliport HLS);
- 2.2 Maintain such employer's liability insurance as is required by law, regulations or orders;
- 2.3 Procure that the Company is named on the Customer's Third Party and Public Liability insurance policy as an additional assured, and that the relevant underwriters have agreed to waive subrogation rights against the Company;

2.4 Produce to the Company on demand at any time before any use of the Falcon London Heliport HLS, originals or copies of the insurance policies above mentioned and written confirmation from the Customer's insurers of the matters referred to above.

3.0 The Customer shall warrant and undertake to the Company that:

3.1 The Customer will be the legal owner of or otherwise be legally entitled to use any and all helicopters using the Falcon London Heliport HLS, and shall hold all licences, approvals, certificates and any other documentation required for the operation of any such helicopters and the flights of such helicopters to and from the Falcon London Heliport HLS.

3.2 Any and all helicopters using the Falcon London Heliport HLS will be maintained in a fully safe and operational condition;

3.3 Any and all pilots operating any helicopters using the Falcon London Heliport HLS shall have the requisite licences and authorisations for such operations from the Civil Aviation Authority and any other relevant body or organisation;

3.4 The Customer shall comply and ensure that their officers, employees, servants and/or agents (including helicopter pilots) shall comply with all statutory and other obligations relating to the possession and/or operation of any helicopters using the Falcon London Heliport HLS.

3.5 The Customer shall at regular intervals survey the HLS/landing sites to assess the access for both helicopters, passengers and cars and be satisfied with their safe suitability for the Customer's intended purpose.

3.6 For the avoidance of doubt, nothing in these Conditions constitutes any attempt by the Company to exclude or limit its own or its agents', subcontractors' or employees' liability for negligence causing death or personal injury.
